2015 Annual Report Christian Education Ministry Team

At WPC, Christian Education is sowing, growing and celebrating. At WPC we Build Faith, Family and Fellowship.

This fall we have been averaging 16 children (20 are registered) and 2 adults in Sunday School. That's a lot of sowing and growing. Teachers during 2015 included Kelly Babcock, Aby Teeter, Jody Pruitt, Irene Fadden, James McFarlane, Lynette Cogan, Lou Callerame and Pastor Robin. One wonderful addition to the Sunday School program is to close together in the Fellowship Hall, singing VBS songs, reviewing the story, and praying together before church. Another addition is working on an adult conversation off church property. Meetings have been held 3 times with approximately 6 people each time.

Vacation Bible School was attended by about 36 children each of the 4 days it was held in August. Cim McFarlane and Lisa Premyslovsky coordinated the event held at WPC. 32 adults and youth volunteered to make the week a success. Children learned that Jesus has the power to save, no matter what. Kids loved the songs, crafts, stories, games and snacks. After VBS, kids celebrated VBS during Sunday worship at both WPC and Palmyra Reformed Church.

Kids led the congregation in two "Gifts of the Heart" mission projects. The first was during Lent and items were brought in for health kits. 75 kits were sent to be used in disasters throughout the world. During VBS and August, items were brought in for school kits. 65 kits were sent to be used for children in need of school supplies.

The middle schoolers have been active. Lynette Cogan has provided opportunities for youth to be together in fellowship and service, putting together school kits and ringing bells for red kettles. There are 6 youth in the group.

WPC has 12 women, 2 youth, and 1 man faithfully serving in the toddler room during worship Our youngest members get a chance to stay in worship through children's time and then play together with a loving and caring adult.

Children and youth celebrated during worship. Children ring the bell Sunday mornings and light the candles during worship. Children led worship for Pentecost. Four 2nd graders received bibles during the service. On Joy Sunday in Advent, the children led the service with bible readings, prayers, call to worship, a litany of Christmas remembrances and a wonderful skit with "Joy Man" and "What Does Joy mean to Me." Youngsters of the church reminded the congregation that Jesus is the reason for the season. One college student received a blanket this fall as she went off to Nazareth. During Palm Sunday, there was a loud and triumphant parade by all kids shouting, "Hosanna! Hosanna in the highest!"

For Easter, Christmas, and Valentine's Day, children worked together to make greeting cards for the shut-ins. This has allowed children and older members of the congregation to become better acquainted.

Canal Town Nursery School continues strong. The Universal Pre-K has 16 students. There are 4 Mom and Tots, 18 3-year olds in 2 classes and a class of 5 4-year olds.

The 2015 CE Ministry Team includes: Lynette Cogan, Lou Callerame, Jody Pruitt, Irene Fadden and Cim McFarlane, Sunday School Director, as a non-elected member. The ministry team seeks ways that allow children to feel welcomed and encouraged to learn more about God's love and grace at WPC.

CTNS 2015 Annual Report

This is the 42nd anniversary year of CTNS at Western Presbyterian Church. Again a very successful year, but the report really covers the 2014-2015 and 2015-2016 years. Our school year is from September to June. As a result, changes in employment occur in the middle of the year. For the 2014-2015 year, the teachers were: Jody Pruitt, Linda Pecora, Lisa Perry and John Antonassio. The enrollment for the 3 s class was 24, the UPK was 16, and the non UPK 4 s was 4.

Activities included the ever popular Pasta dinner and Easter Bunny Breakfast, for which Roxanne Kachel is so valued. In March and April, there were visits to the fire station, the police station, the library, and from a nutritionist about healthy eating. Our teachers attended an Early Childhood Education workshop and fire drills were given regularly. The state requires that 8 fire drills be done in the fall and 4 in the spring.

For the fall school year of 2015, Robin Lindstrom replaced Mrs. Pruitt teaching the 3 s class. Lisa Perry and John Antonassio continued with the 3 s and UPK classes. The school follows the Pal-Mac CSD calendar and opened with a boom at the Meet the Teachers night with enthusiastic children and parents. Trips to Chase Farms for a hay ride, apples, labyrinth, and farm animals were well received. Nature Phil showed up one day with his tortoise and guinea pig to play with. There was a Thanksgiving feast day, visits from Santa and a rousing Christmas celebration and concert.

The CTNS does evaluate the students it is working with and cooperates with the Roosevelt Center in Newark with students who need just a little extra. The Dial 4 assessments for the 4 s is done to judge their progress according to state guidelines. A very special thank you needs to go out to our aides and substitutes Maria Palmer, Keri Devlin, Heather Edlund, Jan Taylor, Ruth Dantz, Joan Durfey and Sara Bush who help the teachers in so many ways.

The Board would like to thank Rev. Nancy J. Farrell, interim Rev. Robin Lostetter, the Session of Western Presbyterian Church and Society and the congregation for all their steadfast support.

In 2015, the Communications Task Force deliberated over the changing nature of current culture and society and the ways involvement in the church is impacted. We sought to identify ways to build and encourage opportunities for members of the congregation to participate in the church's work. The notion that Session and its component teams are tasked with welcoming participation by the congregation guided our efforts.

The "brand" document developed through our work with the Ad Council continues to provide a guide to our work. We established a format for presenting "projects" that had clearly defined scope and allowed members who are unable to accept a long-term commitment to participate. In 2015, we identified a number of projects (logo development, audio/sound project, name tags, rear entrance rehab) that were posted on the bulletin board outside the church office. The name tag project has been implemented. Currently teams are working on logo development and audio/sound.

Additionally, in response to requests from a number of members, a binder was created to house team/committee minutes as well as Session minutes. The binder is located on the credenza outside the church office.

Your 2015 Deacons Ministry Team was dutifully served by Barbara Bucknam, Eugene Bucknam, Sara Bush, Terry Goodwin, Madelyn Jagger, Sandra McMenamin, Linda Pulcini, and Nancy Talma. The weekly prayer lists in our Sunday bulletin reflect their call for prayer and visits.

We fulfilled daily prayer requests for congregation members and many others. Our published list is very fluid, with weekly additions and removals. We pray for lost loved ones and those who grieve. We pray for God to be at the side of those serving our military. We pray for those among us who are expecting to give birth to God's wonderful creations. We joyfully pray at their birth. There is a continual need to pray for the acutely and chronically ill, those for whom age has taken its toll, and for God's care and safe return of those who travel afar. It's very uplifting to read cards and letters we receive in response to our prayer ministry.

Deacons ministered to those who are shut-in and hospitalized. It's truly an awesome and yet humbling feeling, knowing how receptive they are for our visits. When I ask if I may return for future visits, I've never been denied. During the course of the year we repurposed and delivered flowers that had served their purpose in our church, to uplift spirits and hopefully bring a smile. Your poinsettias served that purpose too.

At each monthly meeting, we added scripture and notes to greeting cards, provided by Sandy McMenamin, to send out to those on our extended care list. And, throughout the year, Linda Pulcini mailed cards to congregation members and others, in celebration and to offer comfort.

Our Sunday School children offered their talents too, by creating beautiful greeting cards in celebration of Valentine's Day and the birth of Jesus Christ. They were delivered to our shut-ins and others. During Advent, we stuffed gift bags with various items to accompany those beautiful cards.

The Deacons do not have a budget supported by congregation pledges. We rely on free will donations to finance our annual endeavors. Deacons Fund envelopes are placed in the pews for that purpose. We were blessed in 2015 to have enough funds on hand to fulfill a request from Nancy Farrell to support a Good Neighbor Fund application for assistance.

Deacons are responsible for preparing the elements for communion each month, and for special liturgical occasions. They then clean and put away the silver pieces and communion cups afterward. The communion counts, another responsibility, are shown in the accompanying activity table.

On December 13th, we hosted the coffee hour and a cookie exchange. We had a great time trading cookies.



Finance Team Year-End Report – 2015

For 2015 Western Presbyterian Church continued full financial support for our ongoing programs in Worship, Christian Education, and generous Mission Outreach to both the local and extended global communities while maintaining our **WPC SOURCE OF OPERATING FUNDS**

operating budget in the black. The source of funds for the church is shown in the chart to the right and underscores the **importance of member donations.** Without the faithful and generous contributions of our members, the important work of our church would not be able to continue. In 2015 there were 97 members who donated \$120,576 to the work of the church. This amount represented 72.5% of the church's total receipts. A sincere thank you to each and every one. Also, in addition to providing 25%



of the funds needed for operations, income from our endowments provided \$40,000 for upkeep and improvements to the edifice.

The year 2015 was not without its financial challenges. Last year, too many of our faithful seniors were called home to be with the Lord, leaving a large financial hole to fill. However, due to the reduced expense of pulpit supply arising from the retirement of our Pastor, our operating results nevertheless finished the year in the black by \$12,816. In response to our evolving financial environment, the Finance Team focused on an important project to redefine the Endowment Distribution Policy which was approved by Session in the fall. The policy provides a conservative, yet supportive approach to endowment distribution to support the work of the church.

In a year which saw increasing volatility and challenges in the financial markets, financial advisors Howe and Rusling professionally allocated and diversified our endowment investments to limit portfolio capital loss to a small -3.8% while at the same time earning a 4% income to help fund church operations as well as maintenance and improvements to the edifice.

Many thanks to individuals serving on the finance team. Their faithful service and caring oversight of financial matters allowed WPC to continue important services and missions. It has been an honor to work with Lois Daniels, Irene Fadden, Rena Haigh, Randy Kennard, and Dick Kirchhoff, together with ex-officio members Eric Chapman, Treasurer and Val Gendron, Bookkeeper. Key projects beyond the daily financial management for the church included:

- 1. Completing a successful external audit.
- 2. Budgeting for 2016.
- 3. Coordinating the 2016 pledge campaign and mailing.
- 4. Recommending to Session a new Endowment Distribution Policy.
- 5. Coordinating endowment oversight through Howe & Rusling.

2015 Mission and Social Concerns Team Annual Report

Committee Members: Edie Chapman and John Cook, Co-chairs, Janet Barager, Lou Callerame, Sally Chase, Fred Coffman, Lois Daniels, Ruth Dantz and Jan Taylor

Our team was very active this year and we met each month to support all our projects. Western Presbyterian Church has a long tradition of service and we are challenged to continue this active service to our neighbors both near and far.

Ongoing local projects: We have continued to support the Food Pantry, Home Meal Service, Victim Resource Center, and the Clothing Cupboard. We sponsored grants through the Geneva Presbytery that resulted in an additional \$4,000 for the Victim Resource Center, \$2,000 for the Food Pantry and \$1,500 for the Home Meal Service. One of our members committed herself to buying 1,000 boxes of cereal for the Food Pantry in a 12 month period. As a result of her commitment, the Mission Team has challenged the WPC community to match her goal during the next 12 months.

Holiday outreach: We again sent greeting cards and monetary gift cards to one of the local ARC homes for Christmas. We also sent Valentine cookie boxes to our college students.

Blood Drive: We hosted a blood drive on April 24 with 23 donors.

Global Mission: We continued to support the Qholaqhoe Mountain Connections and featured this mission to Lesotho at our Mission Sunday worship in September. We also challenged our congregation to increase our One Great Hour of Sharing to \$1,000 and actually received \$1,200. We have recently started to collect empty medicine bottles to help the clinics in Malawi dispense medication efficiently to their patients and have gotten a very positive response. We aided the Sunday School with postage funds for two of their mission projects; disaster relief packages and school supply packages.

New Projects:

(1) **Summer Lunch Program:** We were pleased to partner with the Palmyra Community Library, Pal-Mac Central Schools, the Rotary and Lions Clubs to provide free lunches to children up to age 19. Our willingness to organize the volunteers for this free program made it possible to serve 300 meals during 5 weeks of the summer.

(2) Weekend Wellness Program: We have committed our volunteers to purchasing, packing and delivering bags of food to the primary and middle schools to provide extra food to needy students over the weekend. We are currently preparing 44 bags for the Primary School and 26 bags for the Middle School. This number will grow as the High School is added. The Intermediate School's program is administered independently by donations and a family that packs the meals. This Weekend Wellness was suspended during the 2014-2015 school year because the Primary School did not have space to store the food or the staff to administer it. Thanks to the Property Team, we have set up a storage and work room in the old kitchen.

Thanks to the Mission Team, we have 4 teams of shoppers and packers. We had some seed money from previous donations but will need to pursue additional donations to complete the current school year and be ready to start up again next September.

(3) The Good Neighbor Fund: Following Rev. Nancy's retirement, the Good Neighbor Fund was suspended for three months while the Mission Team worked to reorganize this long-time benevolent program. In October with the Mission Team oversight, a team of five lay volunteers representing 3 local churches were able to start interviewing potential recipients for the Good Neighbor Fund. We have raised approximately \$6,000 including \$1,550 from the Advent Concert offering. We have distributed approximately \$4,000 to 11 adults and 10 children in need. We expect that our current organization will be sustainable.

(4) **Palmyra Community Library Snack Program:** At the request of the Palmyra Community Library, the Mission Team has agreed to provide snacks for their Monday & Thursday snack program. Many hungry children visit the library after school. The Circle IV is also supporting this outreach.

We are grateful for the generous participation of the congregation and the co-operation of many community organizations and churches. We're looking forward to working together to continue the mission work of the Western Presbyterian Church.

- Expenses approximating \$1k each: repairs, janitorial/paper supplies, trash disposal, water supply

We also commenced a building inspection using \$900 from edifice funds to inform our strategic planning.

Significant Activities and Notes

- Thanks to Kathy, we have an updated inventory of building keys.
- We had many volunteers join us in spring for grounds clean-up and meet Larry day.
- Property team provided epoxy paint for Phil Opdycke to repaint the backstairs and muscle room.
- In partnership with CE, we cleaned the classroom carpets, the closet, and the green room.
- In partnership with Mission, we cleaned the basement kitchen for the backpack program.
- We replaced the garbage disposal and dishwasher booster heater, re-plumbing some pipes.
- The gap between Fellowship Hall and the sidewalk was cleaned and resealed for winter.
- We have instituted a message board to further open communication with the congregation.
- We have installed 5 CO detectors throughout the facility.
- We continue to be blessed by the services of Larry Sprague as our custodian.

Then on October 4th, all of our WPC family welcomed our new Transitional Pastor Robin Lostetter. Having Robin with us is truly a blessing. We are grateful for her presence and leadership as we continue this journey of change.

ANNUAL REPORT, 2015 Transitional Pastor/Robin Lostetter

As transitional pastor, my basic tasks include the usual pastoral duties, but with a twist: while carrying out those duties, it is my job to assess congregational health and needs, deal with any congregational grief, challenge traditions and introduce new ideas, and thereby "make the way straight" for the next installed pastor.

Having been here only three months, clearly I have only begun this process. My assessment so far includes:

- This is a congregation with a big and generous heart. Generosity guides both mission and internal interactions. Fellowship is nurtured and greatly enjoyed . . . we share food and sit at table together frequently.
- The elders on session upon my arrival are skilled and function appropriately. The pastor is not expected to over-function, is not expected nor needed to attend every team meeting, and is thereby allowed to function more appropriately her/himself.
- Congregational care is handled both compassionately and efficiently. Not only is there genuine care and concern for each other, but the coordination of who/what/when by the Deacon co-chairs is kept up-to-date and the confidential list is cleared out regularly. This is made possible because the congregation is trained to follow up.
- Mission and social concerns are active at Western Pres. From areas that every member can participate in (the cereal challenge and collection of plastic bags and prescription bottles); to active shopping, bagging, and delivering of food; to para-professional counseling through the Good Neighbor Fund this congregation is making a strong local impact. Their gift to One Great Hour of Sharing was increased this year, and it would be great if their historic gift of a well in Kenya were to be repeated, to increase their global efforts. In all their mission work, WPC partners with others and seeks grants, in order to maximize their resources.
- Christian Education is alive and well! Not only are the kids enthusiastic, but they consistently display biblical knowledge at the Children's Time in worship. We anticipate growth in the Adult Education area, and participation among our youth in Triennium and/or a Mission Trip this year.
- Worship is the focal point for much of the congregation, and the Worship Ministry Team is a well-oiled machine! Our musicians are gifted, creative, & dedicated! Within the congregation's usual traditions, we have introduced several changes in the past three months, opening the doors for the next pastor to make changes as well. Feedback has been generally positive.
- The work of the above teams is supported by exceptional Finance and Property Teams. I urge everyone to read their reports. The fruits of their labors include a building that can be maintained primarily through endowment funds well into the future, as a locus for community service, independent of ups and downs in membership and general budget concerns.

Perhaps the biggest challenge is seen as the congregational Nominating Committee goes about its work. With the formation of a Pastoral Nominating Committee, new leadership for Session and Ministry Teams is stretched. This, of course, points to the need for growth among membership in the age groups who can provide active leadership and participation. For now, we will live with being "stretched," but a primary concern for WPC is finding ways to make known our strengths among the unchurched or church-seekers in the community, so that we might begin to add them enthusiastically to our numbers. This goal will undoubtedly require new vision, new practices, members making personal invitations, and the dreaded word: CHANGE. If we continue doing what we've always done, we'll continue to get the same results: a small increase in membership that cannot balance the loss due to age or "snow birds."

This is not an institutional survival concern. This is a concern for the mission of Christ's Church, in the Reformed Tradition, here in Palmyra. We need to be Reformed and Always Being Reformed, as we take seriously our mission to nurture spiritual growth, joyful fellowship, meaningful community and global involvement; worshipping and serving God with *energy, intelligence, imagination and love*.

2015 Canal Town Days Event

The Change to Spudtacular:

A Spudtacular was held in place of The Ox Roast after 40 great years. In recent years it had become increasingly difficult to find volunteers to lead the Ox Roast. For the past several years, the cost of materials, especially the beef, has made the Ox Roast less profitable than in prior years. The resources required (time, talents, energy, money) for a small actual dollar return, based on sales, suggested the Ox Roast was not a viable option for this year. If the cost to our patrons was increased to attempt to maintain profits, then the cost would be more than many families could reasonably support.

A Spudtacular was chosen since it should have little overhead and require fewer resources. Baking potatoes are reasonably affordable, and the cooking time allows staggered batches so we can respond to changes in demand during the day. Toppings could be maintained in slow cookers or ice baths as needed. The cost was reasonable for this type of food during the Canal Town Days celebration. Almost all of the materials and food stuffs were donated by members of the church.

If leaders are found and can start earlier in the year, the event can be even more successful each year. Having a brochure or pamphlet available for patrons to learn more about worship at WPC and our mission activities would help to educate and welcome additional people. If Fellowship hall is not used for serving food, then could it be used for additional mission (blood drive, back-pack filling, food cupboard donations) or educational (WPC, Presbyterian Church mission, CTNS) purposes?
